

## When trading Bitcoin, you buy at ask and sell at bid including commission, respectively. The Bid/Ask difference is called spread







## For facilitating trade between two parties liquidity provider receives the spread less commission paid to exchange

### Liquidity providers (market makers)

- make it easier to buy and sell by continuously quoting buy and sell prices.
- Earn therefore a spread less exchange commission.
- Spreads tend to be higher, the higher the volatility in a market and the lower the transaction volume (compare spreads before big news events).






## Bitcoin transaction volume has steadily increased and remains fairly stable compared to volatility in price







## High spreads and high transaction volume offer currently unique daily returns of 4% for liquidity provider






### Main takeaways

- Like at the traditional stock market liquidity providers enable smooth transactions on the crypto markets
- To profit on the bid/ask spread depends on the amount of transaction rather than on the bitcoin price
- Therefore, risk is comparably low given stable transaction volume and returns high, which makes it an unique investment opportunity






## **FAQs**



### **Anonymous Trading**

#### F: Where is Anonymous Trading registered?

A: Anonymous Trading is duly registered and is also subject to the tax and legal conditions of Anonymous Trading's country of domicile.

#### F: Does Anonymous Trading act as liquidity provider?

A: No, Anonymous Trading is a consortium member of several liquidity providers and has a contractual relationship with them.

#### F: Is Anonymous Trading licensed for what it does?

A: Anonymous Trading holds a trading license in the country of domicile. Anonymous Trading does not require to have a banking license, since it is a trading company.

### F: How do I know that investing with Anonymous Trading is an opportunity?

A: Anonymous Trading offers the opportunity to participate in the trading profits of the Liquidity Provider. Profits depend primarily on the transaction volume with which cryptocurrencies are traded and not on the price developments of the cryptocurrencies. Anonymous Trading operates in a niche market and is not comparable to other market offerings currently.



### Account, deposits & withdrawals-part 1

F: How can I make a deposit?

A: Anonymous Trading offers various deposit options. These include Bitcoin (BTC), USDT (\$Tether), credit card or bank transfer.

F: Can I deposit Dollar and Euro?

A: Yes. Please contact our support team.

F: Where is my money deposited and who manages the money?

A: The money is transferred to the Liquidity Provider on a collective wallet.

F: How long is my invested capital tied-up at Anonymous Trading?

A: The term depends on the account. The term for a Bronze, Silver and Silver Plus account is 6 months. For all other accounts, the money is tied up for 12 months. (Note: The bonus has a term of 12 months for all accounts).



### Account, deposits & withdrawals – part 2

F: Can I make additional deposits into an existing account at a later point in time?

A: Yes, this is possible at any time during the lifetime of the account.

F: What happens, if I upgrade to higher account type by making additional deposits? Does the term start over again?

A: IF a higher account type is achieved through additional external payments (i.e., not through reinvestments from the cash balance), the "incentive bonus", received so far will be deducted (e.g. the 20% of the Bronze account). Then the bonus of the new account type (e.g. 50% with Silver) is added. This does not change the running time of the account.

### F: Why is there not a KYC process?

A: The basic idea behind the introduction of cryptocurrencies has always been absolute decentralization and anonymity. Anonymous Trading follows this principle and offers it's service "offshore". A KYC is therefore not required.

F: Why don't I get a bonus, if I reinvest the existing cash contributions on my dashboard?

A: The incentive bonus is only granted on new deposits from "external". Cash amounts from \$ 100 can be paid out to an external wallet. If these amounts are then paid in again, the incentive bonus will be granted.



### Account, deposits & withdrawals-part 3

### F: Is there a minimum deposit amount and a withdrawal limit?

A: The minimum deposit for an account is \$500 for the Bronze Account. AnonyCoins can already be purchased with an amount of \$100 (please consult the support team). The minimum withdrawal limit from the account cash balance is \$100 (for Affiliate Benefit Credit the limit is \$250.)

#### F: How fast are pay-outs for cryptos processed by Anonymous trading?

A: Every withdrawal request is processed within an hour. Depending on the traffic on the blockchain, the payout takes between 30 minutes and 4 hours.

#### F: How can gains be paid out?

A: In principle, winnings are paid out in USDT ERC20 (Ethereum network) or USDT TRC20 (Tron network). A payout via international bank transfer to a bank account is possible. There will be an upfront transfer fee of \$50.

### F: Does Anonymous Trading charge any commissions to manage, deposit and pay-out of funds?

A: No, Anonymous Trading does not charge any fees from its investors.



### **Affiliate Program**

#### F: Where do I find my personal affiliate - link?

A: After logging into the affiliate dashboard at https://affiliate.matrix.anonymoustrading.io/ with the name and password used to log into the trading platform, go to menu point "Campaign". There you 'll find your personal affiliate link. If interested parties register with Anonymous Trading via this link, they automatically appear in your downline.

#### F: How is the volume calculated for affiliates?

A: There are three ranks. In order to advance from silver rank to gold rank, the people you referred directly (=level 1) must have invested more than \$50,000. In order to advance from gold to platinum, all deposits made by your downline (level 1, level 2) are added together. If this total exceeds \$100,000 then you will achieve platinum rank.

#### F: Are deposits from my account added to the affiliate volume?

A: Deposits on your account are not added to the volume. However, deposits made by you on your sub-accounts (maximum 3-4) are added to the volume.



### AnonyCoin

#### F: What is the technical basis of AnonyCoins?

A: As a so called settlement coin, the AnonyCoin is a fully-fledged coin (not a token) and can be used for payment transactions. The AnonyCoin is based on the Crypto Note technology and is mineable.

#### F: How many AnonyCoins will there be in total?

A: 10 million AnonyCoins will be available for sale during the ICO presale. Therefore, the coins purchased during the presale will be the maximum coins available.

### F: Are anonymous transactions actually feasible with AnonyCoin – and if so, why?

A: Definitely yes! The AnonyCoin is designed as a "privacy coin". For each transaction the sender, recipient and amount are hidden. This is enforced by strict consensus rules. Addresses will never appear on the blockchain. Instead, funds are transferred via stealth addresses. This completely precludes people from monitoring you by searching your address for related transactions.



### Other

#### F: Can Anonymous Trading be hacked?

A: Since all customer deposits are made directly to a "cold wallet" or account of the liquidity provider, even a successful hack attack on Anonymous Trading would not endanger customer funds. Nevertheless, Anonymous Trading has a corresponding security system.

#### F: Are there any implications for Anonymous Trading, if Bitcoin or USDT crashes?

A: Customer profits depend on the transaction volume of the cryptocurrencies traded and not on the price of the cryptocurrencies. A crash could lead to a low trading volume. However, in such an event Anonymous Trading could switch to other cryptocurrencies that have the necessary trading volume.

#### F: Why is there no imprint on the Anonymous Trading homepage?

A: Anonymity and discretion are important to protect the business model, customers and business partners. In the country where Anonymous Trading is based, there is no obligation to provide an imprint.

#### F: Why does a liquidity provider need retail investor funds?

A: A liquidity provider always has an interest in having additional financial resources at their disposal in order to expand their business activities. Building a financially strong pool of retail investors to counterbalance institutional investors is an approach that Anonymous Trading pursues through its business model.
