



*Membership is available to SEC registered broker-dealers who have obtained a self-regulatory organization and have an established connection to a clearing house; currently 152 NYSE members


Crypto markets are less regulated, global and always open (24/7), but also require designated stakeholders to enable fast & orderly markets




Bitcoin transaction volume on exchanges has steadily increased and remains fairly stable compared to high volatility in price



Both, a high amount of transactions as well as a high volatility in price are beneficial for liquidity providers and scalp traders.




Exchanges receive commission for matching buyer and seller. However, to offer fair prices & fast execution liquidity is needed



Spreads tend to be higher, the higher the volatility in a market and the lower the transaction volume (i.e., spreads before big news events).

Emerging and fast growing crypto trading infrastructure requires high amount of liquidity, which offers an unique investment opportunity



All supporting factors are currently in place in the crypto markets to boost daily investment opportunities

Spread: In times of increased volatility the spread increases (and vice versa). Also dependent of exchange platform terms.

Main takeaways

- Like at the traditional stock market liquidity providers enable smooth transactions on the crypto markets
- To profit on the bid/ask spread depends on the amount of transaction rather than on the bitcoin price
- Therefore, risk is comparably low given stable transaction volume and returns high, which makes it an exceptional investment opportunity






